Dear Secretary Granholm:

The Defense Nuclear Facilities Safety Board (Board) reviewed the Department of Energy's (DOE) revised directive, DOE Order 151.1E, *Comprehensive Emergency Management System*. DOE Order 151.1E retains improvements resulting from Board Recommendation 2014-1, *Emergency Preparedness and Response*, and clarifies several requirements. Implementation of DOE Order 151.1E will benefit emergency preparedness and response across the defense nuclear complex.

However, the Board is concerned by the National Nuclear Security Administration (NNSA) Administrator's memorandum dated September 18, 2023, which advised NNSA field office managers to delegate to their contractors the approvals of revisions to some emergency program documents, including all-hazards surveys, emergency planning hazards assessments, and emergency exercise plans. The Board considers this guidance to be inadvisable and inconsistent with DOE Order 450.2, *Integrated Safety Management*, which states, "DOE's safety management responsibilities for ensuring adequate protection and safe operations must be met by DOE line management and cannot be delegated to contractors." All-hazards surveys and emergency planning hazards assessments establish the technical planning basis for emergency action levels, protective actions, and emergency planning zones. Emergency exercise plans define the scope of testing and validating emergency plans.

The Board urges NNSA to issue revised guidance to ensure that emergency program documents that affect safety at defense nuclear facilities receive federal review and approval consistent with DOE Order 450.2. Further, the Board advises the Department to update DOE Order 151.1E to codify this guidance at the soonest opportunity.
