Dear Mr. Chairman:

Commitment 4.1 of the Department's Implementation Plan for Defense Nuclear Facilities Safety Board (Board) Recommendation 95-2 required the Department to revise the existing Functions, Responsibilities, and Authorities Manual (FRAM) by September 18, 1996. A December 30, 1996 letter updated the Board on the Department's activities related to developing and issuing the FRAMs. The FRAM documents will consist of a corporate (level 1) FRAM and secretarial and field office (level 2) FRAMs. The Department committed in the December 30, 1996 letter to issue the level 1 FRAM and the level 2 FRAMs for the secretarial and field office managers associated with the ten priority facilities identified in the 95-2 Implementation Plan by May 1997.

The Safety Management Implementation Team has made significant progress in developing the FRAMs and is ensuring that this effort is consistent with the safety management functions instituted pursuant to the 95-2 Safety Management Implementation Plan. The draft corporate level 1 FRAM and draft level 2 FRAMs are being forwarded by this letter for your review and comment. Comments are requested by June 30, 1997 to support issuance of the FRAMs in 60 days. There are continuing integration issues with the secretarial and field office level FRAMs which will be resolved prior to issuance, as well as other issues requiring senior management attention, such as the "120-day report." The level 2 FRAMs associated with the priority facilities and submitted as Attachments to this letter are listed below:

- The level 2 FRAMs for the secretarial and field office managers associated with the ten priority facilities identified in the 95-2 Implementation Plan will be integrated and completed within 60 days.
- The appropriate Secretarial Officers and Field Office Managers associated with the priority facilities will be prepared to brief the Board in 60 days.
