The vote on this motion commenced without any discussion after the motion was made. Further, the motion made was at odds with some of the conversation. First, the majority of the Board spoke in favor of holding the meeting only after we had moved far enough in the evaluation process of the staff's orange folder proposal to understand the numbers and types of amendments and to post them publically. This would have meant not fixing a date, even with the contingency provided (which was discussed and articulated after the vote was taken). Additionally, the motion contained a decision to not have a specific time allotted for public comment. This is inconsistent with Board procedures and is inconsistent with the whole notion of having public meetings in order to engage the public.
